## THE CITY OF ST. MARY, MISSOURI

Board of Aldermen Meeting Thursday, July 23<sup>rd</sup>, 2020 6:00 PM

- **1. Be it Remembered:** A regular meeting of the St. Mary Board of Aldermen was called to order by the Honorable Mayor Carl Wyatt on Thursday, July 23<sup>rd</sup>, 2020 beginning at 6:00 p.m. at City Hall located at 782 3rd Street, St. Mary, Missouri 63673.
- **2. Pledge of Allegiance:** The meeting was opened with the Pledge of Allegiance to the Flag of the United States of America.
- **3. Roll Call:** Aldermen answering the roll call were Alderman Jennifer Schwartz, Alderman Clyde Cassoutt, Alderman Zen Duda (arrived at 6:06 p.m.), and Alderman Annette Hacker.
- **4. Agenda:** A motion was made by Alderman Clyde Cassoutt to approve the agenda. Alderman Jennifer Schwartz seconded the motion. Alderman Jennifer Schwartz, Alderman Annette Hacker and Alderman Clyde Cassoutt voted yea on a voice vote. Motion carried.
- **5. RESOLUTION FOR AUTHORIZED BANK SIGNATORIES:** A motion was made by Alderman Jennifer Schwartz to approve Alderman Clyde Cassoutt as the Bank Signatory (in addition to Mayor Carlton Wyatt and City Clerk David Woods). Alderman Clyde Cassoutt seconded the motion. Alderman Jennifer Schwartz, Alderman Annette Hacker and Alderman Clyde Cassoutt voted yea on a voice vote. Motion carried.
- **6. UTV Ordinance Amendment Discussion:** The Honorable Mayor Carl Wyatt discussed issues with the recently passed UTV Ordinance. The board came to a consensus to make the following changes and additions. Minimum age will be 16 years old with a valid driver's license. Helmets will be required. Headlights will not be required during operation of UTV and Golf Carts. There will be no operation of a UTV or Golf Cart from ½ hour after sunset until ½ hour before sunrise. The Board read the email from our insurance carrier that says we should require the operator's insurance to clearly states that coverage includes city streets. The board came to a consensus that burden cannot be met and that we would require liability insurance and have the operator sign a waiver with a release of liability. The location of the permit sticker shall be the lower corner of the windshield on the passenger side. Golf Carts shall not have a specified power source. Anyone who violates the rules twice in a one-year period shall have their permit revoked for one year. The turn signal requirement shall be combined with the brake light requirement.
- 7. City County Stormwater Project: The Board reviewed the map from the previous administration of the ditches that they wanted the county to assist us with. There was a consensus that Cedar Street should be a priority and the Franklin Road should also be addressed. Franklin Road is riddled with potholes and Franklin Bridge is a County Asset that they received FEMA funds to improve.
- **8. Regular Session Adjournment:** There being no further business before the board, a motion was made by Alderman Clyde Cassoutt to adjourn at 6:50 PM. Alderman Jennifer Schwartz seconded the motion. All the aldermen voted yea on a voice vote. Meeting adjourned.
