**1. Be it Remembered:** A regular meeting of the St. Mary Board of Aldermen was called to order by the Honorable Mayor Carl Wyatt on Wednesday, September 30<sup>th</sup>, 2020 beginning at 6:00 PM at City Hall located at 782 3rd Street, St. Mary, Missouri 63673.

**2. Pledge of Allegiance:** The meeting was opened with the Pledge of Allegiance to the Flag of the United States of America.

**3. Roll Call:** Aldermen answering the roll call were Alderman Ron Barnett, Alderman Karl Schultz, Alderman Zen Duda and Alderman Annette Hacker.

**4. Agenda:** A motion was made by Alderman Ron Barnett to approve the agenda. Alderman Karl Schultz seconded the motion. Alderman Ron Barnett, Alderman Karl Schultz, Alderman Zen Duda and Alderman Annette Hacker voted yea on a voice vote. Motion carried.

**UNFINISHED BUSINESS**

**5. BILL NO. 967 - AN ORDINANCE ADOPTING AN ANNUAL BUDGET FOR THE FISCAL YEAR BEGINNING ON OCTOBER 1, 2020 AND APPROPRIATING FUNDS PURSUANT THERETO.**

Alderman Annette Hacker made a motion for a first reading of bill 967 by heading only. Alderman Karl Schultz seconded the motion. Roll Call Vote: Alderman Ron Barnett (aye), Alderman Karl Schultz (aye), Alderman Zen Duda (aye) and Alderman Annette Hacker (aye). City Manager David Woods read bill 967 for a first reading by heading only.

**7. Appointment and Acceptance of the New City Collector:** The Honorable Mayor Carl Wyatt nominated Katrina Ullman for the position of City Collector to serve until the next election which is the end of the term. A motion was made by Alderman Ron Barnett to accept the nomination. Alderman Annette Hacker seconded the motion. **8. BILL NO. 970 - AN ORDINANCE REPEALING AND REPLACING AN ORDINANCE 665 ESTABLISHING STOP SIGNS AT DESIGNATED LOCATIONS AND SETTING WHEN THIS ORDINANCE SHALL TAKE EFFECT.**

**9. BILL NO. 971 - AN ORDINANCE REPEALING AND REPLACING AN ORDINANCE 666 ESTABLISHING STOP SIGNS AT DESIGNATED LOCATIONS AND SETTING WHEN THIS ORDINANCE SHALL TAKE EFFECT.**

MARY, MISSOURI, ASSESSMENT OF COURT COSTS, PROVIDING FOR MUNICIPAL COURT BONDS AND PAYMENT IN LIEU OF COURT APPEARANCE.**
