AN ORDINANCE CONCERNING AND EXTENDING THE BOUNDARY LINE OF THE CORPORATE LIMITS OF THE CITY OF ST. MARYS, MISSOURI: CALLING THE ELECTION FOR THAT PURPOSE, DESIGNATING THE KIND OF NOTICE TO BE GIVEN OF THE ELECTION, AND THE TIME AND PLACE TO HOLD THE SAME, AND APPOINTING THE JUDGES AND CLERKS OF THE ELECTION.

Be it ordained by the Board of Aldermen of the City of St. Marys, Missouri, as follows:

Section 1. That by virtue of the consent of a majority of the legal voters of the City of St. Marys, Missouri, at an election to be held in accordance with Sections 79.020 and 79.030 of Ch. 79 and Ch. 111, of the Revised Statutes of Missouri, 1949, on SEMBMENT Tuesday the 17th FERT day of February 1953, after giving of notice of the election as hereinafter provided, the consent of the majority of the legal voters of said city voting at said election therefor, the corporate limits of the City of St. Marys, Missouri are hereby extended and defined as follows:

Section2. That the present corporate limits or boundary line of the City of St. Marys, Missouri, is as follows:-

Beginning at the Southeast corner of Fifth Street and Sycamore Street in the City of St. Marys, Mo., said point of beginning being a point on the present corporation line.

Running thence S. 40 deg. W. a distance of 185 feet, with the West line of the First Prince Gardner Addition to the City of St. Marys, to a point for a corner. Thence S. 32 deg. West 490.60 feet to a corner in the South line of Seventh Street. Thence with the South line of said Street S. 50 deg. E. 745 feet to a corner in the West line of Pine Street. Thence S. 20 deg. E. a distance of 828.50 feet to the Northwest corner of Prince GardnerSecond Addition to the City of St. Marys. Thence S. 46 deg. 09' East 291.40 feet to a corner. Thence 5.21 deg. 23' E. 238.30 feet to a corner. Thence S. 52 deg. 27' E. 138.25 feet to a corner. Thence S. 28 deg. 35' E. 169.60 feet to a corner. Thence S. 32 deg. 04' E. 261.20 feet to a corner. Thence S. 61 deg. 02' E. 152.60 feet to a corner. Thence S. 64 deg. 11' E. 75.40 feet. Thence S. 64 deg. 16' E. a distance of 133 feet to a corner. Thence N. 40 deg. E. 243 feet to a point for a corner in the West line of Eight Street, said point being a point in the present corporation line. Thence with the present corporation line, along and with the West line of Eight Street, S. 50 deg. E. to the Burgette Everett Spring Branch. Thence bounding on the said Spring Branch, down the same to the St. Laurent Creek. Thence bounding on the said St. Laurent Creek, down the same, to the most Southern corner of Cherry and Fourth Sts. Thence N. 40 deg. E. 150 feet to Third Street. Thence bounding on the Western line of Third Street S. 50 deg. E. to the most Southwestern corner of said Third and Plum Street. Thence N. 40 deg. E. on the Southwestern line of Plum Street to the Mississippi River. Thence up said river, about N. 50 deg. W., bounding on said river to intersect the North line of Elm Street. Thence with the North line of Elm Street S. 40 deg. W. to intersect the North line of John Tlapek's estate. Thence along the North boundary line of John Tlapek estate, Louis Schaaf (C. R. Bartels) Edward Schaaf (Edgar H. Beauchamp) J. F. Bartels Sr. (C. L. Maloney) and Mrs. Geo. Eller's lands, N. 45 deg. W. 1373 feet to where the extension of the line between the Eller's place and T. E. Picou land intersects the South line of the County road. Thence S. 50 deg. W. with said line to a stone at the S. W. cornerof Eller's land. Thence S. 38 deg. E. along the South line of Mrs. Eller's, J. F. Bartels Srs., Edward Schaaf, Louis Schaaf, Walter Schaaf, and John Tlapek, 1358 feet to a point on the Northeastern line of grave yard road 30 feet N. 50 deg. E. from a stone at corner between T. B. Whitledge and Stephen Friedman. Thence S. 42 deg. E. 288 feet to corner of John Tlapek and Rueben Cole. Thence S. 60 deg. E. 700 feet, Thence S. 49 deg. E. 150 feet to the North line of Sycamore Street to the place of beginning.

Section 3. That the above and foregoing provision of this ordinance shall be in full force and effect from and after its ratification by a majority of the votes cast by the legal voters of the City of St. Marys, Missouri, voting at an election held therefor.

"Shall the corporate limits of the City of St Marys, Missouri, be extended and defined as set out in Section 2 of Ordinance No. 241, passed and approved by the Board of Aldermen of the City of St. Marys, Missouri on the 29th day of December, 1952.

Section 7. That notice of election to be held under this ordinance shall be given by publishing a full and true copy of this ordinance in an least one weekly newspaper printed and published in the City of St. Marys, Missouri, for four consecutive weeks, the last insertion to be not more than two weeks before the election.

Section 8. That all ordinances and parts of ordinances inconsistant with this ordinance, be and are hereby repealed, and that this ordinance shall be in force and effect from and after its passage and approval.
