AN ORDINANCE AUTHORIZING THE CITY OF ST. MARY, MISSOURI, TO CONDEMN A TRACT OF 1.00 ACRE, MORE OR LESS, AS WELL AS LOTS NUMBERED 36, 38 AND 39 IN BLOCK 46 OF THE CITY OF ST. MARY, MISSOURI, AND LOTS NUMBERED 13, BLOCK 46 OF SAID CITY AND LOT NUMBERED 20 IN BLOCK 45 OF SAID CITY FOR THE PURPOSE OF CONSTRUCTING A SEWER SYSTEM WITHIN THE CITY OF ST. MARY, MISSOURI, REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH AND DESIGNATING THE TIME WHEN THIS ORDINANCE SHALL TAKE EFFECT.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ST. MARY, MISSOURI, AS FOLLOWS:

SECTION 1: That the City does hereby find that it is necessary to condemn the following tract situate in the City of St. Mary, Ste. Genevieve County, Missouri, to-wit:

Beginning at the Northeast corner of a certain tract of parcel of land where Lot No. 21 in Block No. 45 in the City of St. Mary, Missouri, intersects the 25 foot alley which runs North and South in said Block No. 45 running thence South and along the West line of said alley to a line running in a Western direction and opposite Lot No. 19 in Block No. 45, western direction and opposite Lot No. 19 in Block No. 45, and known as the Frank Waters place, thence West along said line to land owned by August Otte and T. B. Whittledge, thence in a Northern direction to a line where the land of T. B. Whittledge intersects a portion of his own land running East and West thence East and along the line of said land of T. B. Whittledge and the Southern boundary line of Lot No. 21, in Block 45 of the City of St. Mary Misseyri to the place of Block 45 of the City of St. Mary, Missouri, to the place of beginning containing in the aggregate one acre, more or less.

ALSO, Lots numbered 36, 38 and 39 in Block No. 46 of the

City of St. Mary, Missouri.

ALSO, Lot No. 13 Block No. 46 in the City of St. Mary,
Ste. Genevieve County, Missouri.

ALSO, all of Lot numbered 20 ir Block Number 45 in the City of St. Mary, Ste. Genevieve County, Missouri.

for the purpose of constructing a sewage system within the City of St. Mary, Missouri.

SECTION 2: That the City does hereby find specifically that it needs said land for such public purpose as set out in Section 1 hereto and does hereby authorize the City Attorney to bring said action in the Circuit Court of Ste. Genevieve County, Missouri.

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 4: This Ordinance shall be in effect from and after its passage and approval.
