AN ORDINANCE REGULATING MOTOR VEHICLE STICKERS AND STATING WHEN THIS ORDINANCE SHALL TAKE EFFECT.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ST.MARY, MISSOURI, AS FOLLOWS:

#### SECTION 1. LICENSE TAX IMPOSED

Commencing on the first day of January, 1999, and continuing thereafter, there is hereby levied and shall be collected by the City of St. Mary, Missouri a license tax from the owners of motor vehicles, residing within the city limits of the City of St. Mary as follows:

Automobiles \$4.00
Motorcycles
Trucks less than 2 ton
Trucks over 2 ton less than 5 tons
Trucks over 5 tons less than 6 tons \$7.50
Trucks over 6 tons less than 7 tons \$8.50
Trucks over 7 tons less than 8 tons \$10.50

#### SECTION 2. APPLICATION FOR STICKER

Each owner of a motor vehicle upon which a license tax shall be due said City shall apply to the City Collector for such license sticker and shall furnish to said City Collector a description of such motor vehicle including the make, style, and yearly model and applicant for such license sticker shall pay therewith the license tax herein required, and said City Collector shall furnish such motor vehicle owner a city license which said license sticker shall forthwith attach to and display in the lower right corner of the windshield of said motor vehicle, which said license sticker shall bear a City registration number.

#### SECTION 3. DUPLICATE STICKER

In the event of loss of such license sticker of trading of such vehicle said owner shall immediately procure another license sticker from said City Collector for which said motor vehicle owner shall pay a fee of fifty cents (\$.50) and no other charge.

### SECTION 4. TERM OF LICENSE

All motor vehicle stickers shall expire on the Thirty-first (31st) day of December and said motor vehicle owners shall be allowed fifteen (15) days within which to renew their motor vehicle license sticker and pay the license tax herein levied.

## SECTION 5. TAXES MUST BE PAID

No person shall be entitled to be issued a City license sticker to operate a motor vehicle within the limits of said City until he/she has paid both his/her personal property taxes and real estate taxes due and owing to said City, notwithstanding the tender of the City license fee.

# SECTION 6. CITY COLLECTOR'S DUTIES

The City Collector is hereby authorized and directed to procure the necessary license stickers having a permanent bond which shall be procured at the expense of the City of St. Mary.

# SECTION 7. VIOLATIONS OF THIS ORDINANCE

Any person or persons violating any provision of this ordinance shall be deemed guilty of a misdemeanor and said person shall be punished by a fine of not exceeding Five Hundred Dollars (\$500.00) or Ninety (90) days in jail.

All ordinances or parts of ordinances are hereby repealed.

This ordinance shall be in full force and effect from and after its passage and approval.
